By-Laws of the Briaerean Honor Society at The Georgia Institute of Technology

(Revised March 2004)

ARTICLE I: Dues

The amount of dues shall be a one-time fee of forty (40) US dollars.

ARTICLE II: Officer Requirements

Section 1. To be eligible for the office of President, Vice President, Secretary, or Treasurer, a member must be physically available during at least two of the three semesters of duty.

Section 2. In the event that a newly voted officer of the position of President, Vice President, Secretary, or Treasurer will not be physically available for one of the three semesters of duty, an alternate officer will be elected to take the place of the newly voted officer during the one semester absence.

ARTICLE III: Officer Elections

Section 1. The election procedure for officers shall: (a) follow Robert's Rules of Order unless otherwise noted, (b) begin with the election of the President followed by Vice President, Secretary, and Treasurer, and (c) if necessary, the election of alternate officer(s) shall take place after all newly voted officers have been elected.

Section 2. Prior to voting, each member, nominated for office, shall have the opportunity to address the membership body.

Section 3. During voting, the candidates shall leave the room.

ARTICLE IV: Membership Status

Section 1. All members will begin on active status as of Summer 2004. Membership status is reevaluated at the end of each semester. The new status will be in effect for the entire following semester.

Section 2. Two attendance points each semester are required to remain on active status. Each meeting, social event, and initiation ceremony is worth one attendance point. Active members will receive an additional price break for all social events. Members active for at least one of the semesters during their final year at Georgia Tech will receive a green and gold Briaerean Honor Society cord to wear at graduation.
